'Titanic' Produces A Wave of Possibilities for '87 Graduate

For SUNY Utica/Rome alumnus Jeff Ledda voyages to the bottom of the sea, including hovering around the most famous shipwreck in history, didn't seem altogether glamorous, until his name twice appeared on the credits of one of the most successful Hollywood productions of all time.

Ledda assisted in the production of those dramatic opening scenes of the \$200 million epic, "Titanic." A 1987 SUNY Utica/Rome graduate with a bachelor of science degree in electrical engineering technology, Ledda has worked for several underwater companies that assist in research and production of underwater projects and events.

Ledda is credited in the Academy-Award-winning movie for work which included assembling the equipment needed to film the wreck for director James Cameron's Lightstorm Entertainment. Then, from a Russian submarine, Ledda guided a camera-equipped robot in and around the wreck, which lies more than two miles below the Atlantic Ocean surface.

As Ledda worked, Cameron directed the filming from a second submarine. "Working in close quarters in a submarine with someone, you really get to know the person. James Cameron was a normal person, making exciting movies for a living."

While Oscar nominations are likely for the members of the cast of the movie, "some of the people I worked with feel pretty strongly that we'll be nominated for a technical type of an award," he said. "It's actually a very strong

possibility because we developed something very unique and it worked."

Ledda and his wife, Heidi, were invited to a private screening of the movie in Los Angeles. "It was pretty exciting to see all the work come together. When I began consulting for the movie in 1995, the cast members had not been finalized, so to see the movie in it entirety was incredible."

Roots in Rural Herkimer County

Ledda grew up on a farm in Litchfield, N.Y., where his mother still resides. Ledda has three sisters and one brother. His brother Ed is also a SUNY Utica/Rome alumnus, graduating in 1984 from the mechanical engineering technology program. Ed resides in the Utica area. Jeff and his wife, Heidi, a former Utican, reside in Maryland with their three children, Megan, Julie, and Sierra.

Ledda graduated from SUNY Maritime in 1983 with a bachelor of science degree in ocean engineering. He credits his grandfather, a former Merchant Marine officer, for inspiring him to get his first degree in ocean engineering. Ledda claims his interest in oceanography may have also been the result of many Jacques Cousteau movies.

After completing his degree at SUNY Maritime, Ledda worked at Marine Hydraulic in New Jersey for a brief period then landed a job at International Underwater Contractors in City Island, N.Y. It was there that Ledda first used his ocean engineering knowledge

as an ROV (Remote Operated Vehicle) technician/engineer.

His work at International Underwater Contractors was a case of "being at the right place at the right time." His ROV projects included exploring the oil lines in California and working along the Gulf of Mexico. During his employment he had the opportunity to attend ROV Diving School at Hyperbaric Training Center to obtain training as a Life Support Technician. This particular training allowed Jeff the opportunity to provide manned submersible oil rig support for commercial oil companies. One project required one year of

his efforts diving Mantis which was a one-man submarine exploring the Gulf of Mexico.

In 1986, Jeff decided to get out of the industry and return to college. He enrolled in the electrical engineering technology program at SUNY Utica/Rome. His first fiber optics class at Utica/Rome proved to be very useful later on when integrating fiber optics technology into the ROV Industry. Ledda credits Associate Professor Salahuddin Qazi for making this course very interesting.





very interesting and exciting." He also has fond memories of Associate Professor Naseem Ishaq for her electrical engineering courses, which Ledda took while enrolled at the Institute. "I still find myself dusting off my image processing notes when specifying digital cameras to clients."

Ledda has worked for *National Geo*graphic on the Monterey Bay project, which was designed to explore from interface beaches to water at depths of 5,000 feet and lower. The documentaries were designed to show the transitions of the depth of water.

He also assisted in a project on Lake Champlain, investigating the Benedict Arnold Fleet. That became the topic of a program that aired on the National Geographic Channel and the Learning Channel.

Ledda doesn't think he can top the experience he had while assisting in the production of Titanic. "Flying an ROV in and around the most famous wreck is a very tough act to follow," Ledda said. "This project was the ultimate ROV sport drive."

Ledda is now helping to design and build an underwater hull scrubbing machine for the U.S. Navy as part of his work as an ocean engineer for Oceaneering International in Maryland. He took a four-month leave of absence from that job to complete the Titanic project, which began in May of 1995 and was completed in October of 1995.

'Rebel Poet' Lectures on Campus

Dr. Sardar Anjum, of India, a renowned poet-philosopher, who has been described as a "rebel poet," lectured students and other members of the college community during the fall semester.

Dr. Anjum is internationally recognized for his literary versatility, having published his poetry in Urdu, Punjabi and Hindi, the three major languages of the Indian sub-continent.

He is a prolific author, with 18 volumes of his poetry in print.

Dr. Anjum's poetry has been described as a mixture of "fire and fragrance," that reflects both emotional tenderness and harsh human realities. His works are regularly recorded by the most popular singers in India.

For his literary contributions, in 1991 Dr. Anjum received the prestigious Padma Shri Award from India's president — that honor is the equivalent of the Presidential Medal of Arts in the U.S. He has received 12 state awards for his literary works and has been given the title of State Poet of Punjab, his home state.

Dr. Anjum's concern for the human conditions has led him to write, direct and

produce a film dealing with the devastating effects of AIDS. He also wrote, produced and directed the film "Charwah" (The Shepherd), that deals with the "human side" of Jesus Christ

Punjab has been experiencing ethnic and religious conflict and Dr. Anjum has dedicated himself to promoting national integration. His songs and poems have sought to encourage ethnic harmony in his native state. As part of his effort, Dr. Anjum has produced a television mini-series "Goongi Tareekh' (The Mute History/Date), depicting the causes of ethnic turmoil and with a view to facilitate and cultivate peace and tranquility.

He has lectured at the University of California at Berkeley, Bradford University in Great Britain and was recently the guest of honor of the International Punjabi Literary Society in Vancouver, British Columbia.

Dr. Anjum is a former professor and chairman of the Department of Urdu at Panjab University in Chandigarh. He is currently the chairman of the Punjab Arts Council.


State University Honors Outstanding Utica/Rome Alumni



'SpeakEasy' a Connection to Telecommunications History

Recent graduate, David Climek, class of '94, assigned to Rome Laboratory as a research engineer and consultant to the U.S. Air Force, is part of a development team working on a project that could revolutionize the cellular telephone industry and have global significance.

In 1989, Climek was appointed to the development team at Rome Lab. The team was charged with finding a solution to one of the military's communication problems. The U.S. Air Force could not easily communicate directly with all other branches of service by using cellular telephones, according to Climek. Each branch of service used a wireless telephone with a different set of standards. If the Air Force needed to contact the Marines and/ or Army during a close air support operation, the Air Force operations officer would have to call each command's wired equipment. In turn, that command would call their troop operations in the field using wireless equipment. This was time consuming and subject to communication mistakes.

Climek says, the team's solution was "SpeakEasy," a software system capable of listening for a particular standard in a cellular telephone, recognizing that standard, and reprogramming itself to enable communication with that cellular telephone.

Phase I of the SpeakEasy project was to develop a new radio product that would be compatible with all products using "software defined radio" software. The equipment developed in Phase I was the size of a refrigerator, not very portable.

Once the determination was made that equipment could be built for this project, Phase II began. The ultimate goal of Phase II was to get a PC-sized piece of equipment that could be attached to vehicles and used in the field. That goal was realized and, in fact, during the field testing of SDR, the unit fell to the floor and broke its "motherboard." This is a hard flat surface containing the preprinted circuitry and other components of a computer. The simplicity and ease of repair to the test SDR was observed as a regular PC's motherboard

was used as a replacement part for the damaged board. The test unit was put back in service in a matter of minutes.

From the outset of Phase II it was determined that the open system architecture would be commercialized. None of the technology needed to commercialize SpeakEasy was classified. In fact, the commercialization and use of off-the-shelf replacement parts were encouraged by the military as a way of controlling costs.

To ensure participation in this newly-developed technology, the SDR office at Rome Lab formed an International Standards Committee. Climek said this was done so that professionals in the wireless telephone communications field were, literally, on the same wavelength. The committee is known as the MMITS, and is comprised of 35 to 40 manufacturers and users of cellular equipment.

Degree of Success

In the late 1980s, Climek recognized that the bachelor of technology degree obtained from the State University of Buffalo was not sufficient for what he envisioned for his future. He enrolled in the telecommunications program at SUNY Utica/Rome and graduated with a bachelor of science in 1994. He continued at SUNY Utica/Rome and earned his master of science degree in telecommunications in 1997. Climek has the distinction of being the first graduate of the college's telecommunications master program. He has been employed by Mitre Corporation, a management-consulting firm, for 18 years.

During a class presentation, Climek shared the information about SDR. Eugene Newman, Ph.D., director of the master of science in telecommunications program at SUNY Utica/ Rome, expressed an interest in getting involved with the SpeakEasy commercialization. Dr. Newman has since begun a feasibility survey of the Communications Managers Association in New York City and has developed a web page to survey business users in the New York City area to determine if there is a market for this product, and just how big is that market.

Dr. Newman expects to have the results of his data compiled and a final report submitted by the end of May.

A contract between the SDR office at Rome Lab, Dr. Newman, and SUNY Utica/Rome is expected in the near future. In addition to business users, Dr. Newman will be responsible for the feasibility studies of all law enforcement agencies and civil aviation facilities in New York.

Dr. Newman described SpeakEasy as "someone speaking seven different foreign languages." He also predicted that, "there will be a handheld model by the year 2001." If the team doesn't develop this product, someone else will. This is a global problem he said, someone is going to provide the service.

Dr. Newman is proud of his former student's accomplishments, "Dave and the team have done a wonderful thing. They not only attacked a major problem in the wireless phone industry, but also have come up with a solution to that problem. This will bring national recognition to Climek, Rome Lab, SUNY Utica/Rome and the local area."

Climek says, "This will change people's lives in how they use equipment now available. They will be able to consolidate numerous tasks into one hand held piece of equipment. This project will influence the decision to purchase \$10 to \$12 billion worth of radio/cellular telephone equipment over the next 5 to 10 years."

Governor Designates College Among Semiconductor Sites

On March 4, Governor George E. Pataki announced that SUNY Utica/Rome was among the 13 sites across the state selected by Industrial Design Corporation, a consultant hired to provide a professional evaluation of potential sites, as the best suited for semi-conductor development.

According to the governor, the site on the SUNY Utica/Rome campus has the features most important to the semi-conductor industry and are closest to a ready-to-go condition for development, according to IDC's review.

Over the next four years, semi-conductor industry experts expect as many as 35 micro-chip facilities will be built in the United States to keep pace with changing technology in this rapidly expanding market.

"New York State intends to get its share of that business," Governor Pataki said. "By identifying these sites now and getting them pre-approved, we will be able to offer the semi-conductor industry ready-to-go, shovels-in-the-ground locations. In this rapidly changing industry, these sites will give the industry an extra edge so they can stay a step ahead of their competition around the world.

"Given the unique needs of the industry, it's important to note that New York State has so many sites to offer in so many different regions of the State," the governor said. "That alone makes us more competitive."

Chip Fab '98 was announced last December, and set off a process of evaluating 55 sites around the state as potential locations for "chip fabs." Micro-chip fabrication plants cost upwards of \$2 billion to construct and employ up to 1,000 skilled workers each

Siting criteria include an appropriately zoned 200 acre parcel with access to major transportation, plenty of water, two power sources, sewer services and access to academic and vocational resources.

The Empire State Development Corporation and the Governor's Office of Regulatory Reform are leading the effort for the state.

Under the Governor's initiative, ESD will match funds up to \$50,000 each with the 13 communities selected to prepare permit applications, site plans and environmental reviews. GORR will provide the communities permit assistance, and, once a manufacturer makes a commitment to build in New York, the permits will be transferred to the company.

The sites selected, after careful evaluation by the site consultant, IDC, include three in the Hudson Valley, two in the Capital Region, two in Central New York, one in the Mohawk Valley, two in Monroe County and three in Western New York.

MVCC, SUNY Utica/Rome Reach New Agreement

Central New York residents interested in obtaining a bachelor's degree in accounting, business or finance now have a new cost-effective opportunity to do so through a joint admissions agreement between Mohawk Valley Community College and SUNY Utica/Rome.

The agreement will streamline and simplify the application and transfer process, allowing students to know exactly which courses to take at MVCC before transferring to SUNY Utica/Rome. Also, MVCC students, who satisfactorily complete the appropriate program of study, are guaranteed entry into SUNY Utica/Rome's School of Business programs in accounting, finance or business/public management. Those students will receive a full credit transfer.

In addition, students who complete the SUNY Utica/Rome bachelor's degree may apply for entry into a master of science degree program in accountancy or business management, with concentrations in management accounting, finance, health services management, human resource management, and management science. A full-time student could complete both the bachelor's and master's degree programs in three years after completing studies at MVCC.

MVCC Associate Professor Catherine Glod, head of the college's business/management systems department, said, "We are very excited about this agreement. It will reduce admissions paperwork for our students, and clarify the transfer of MVCC credit to SUNY Utica/Rome. It also enables students to maximize the educational resources represented by two fine institutions working cooperatively."

The joint MVCC/SUNY Utica/Rome admissions opportunity is open to student who enroll at MVCC in accounting, banking and insurance, business management, computer information systems, office technologies, and individual studies.

The office technologies curriculum includes executive, legal, information processing, and medical concentrations. In MVCC's business management program, students may select courses to create a specialization in marketing, human resources, international business, computer information systems, and retail.

The panel moderator was Richard Havranek, dean of the School of Business at SUNY Utica/Rome. Al Mario, professor emeritus of finance at SUNY Utica/Rome, coordinated the program

along with Sanjay Varshney, assistant professor of finance.

Networking Night was organized by the Graduate Business Association, a student group that responds to the interests of graduate students in business. The association deals with issues such as curriculum, internships, job searches and placement, networking with the business community, and consulting opportunities.

SUNY Utica/Rome's School of Business offers bachelor of science degrees in accounting, business/public management, finance, health information management, and health services management; and master of science degrees in accountancy and business management, with concentrations in management accounting, finance, health services management, human resources management, and management science.

College May Get Additional Funds

Governor George Pataki has included \$500,000 for SUNY Utica/Rome in his proposed executive budget for renovating and equipping for distance learning initiatives at the college.

Overall, the governor's proposed fiscal plan calls for a \$2 billion infusion into the 64-campus SUNY system over the next five years.

In a statement regarding the State University investment, Governor Pataki said, "On the 50th anniversary of the SUNY system and the 150th anniversary of CUNY, we must do more than celebrate and commemorate, we must seek out new and innovative ways to make New York the best state in America to pursue an education."

SUNY Utica/Rome has been recognized for its innovative distance learning initiatives, including its project in conjunction with the Moscow Institute of Electronics and Mathematics, which made it possible for seven Moscow-based students to earn their master of science degrees from the Institute of Technology.

Nobel Peace Prize Chairman Offers Thoughts to Community

In October, Francis Sejersted, chairman of the Nobel Peace Prize Committee, appeared at SUNY Utica/Rome a few days before announcing the winner of the annual honor and spoke to the college community regarding "Peace, Politics and Technology – "Beyond Technological Determinism."

Sejersted, chairman of the committee that is officially named the Norwegian Nobel Committee also spoke at Colgate University on "The Nobel Peace Prize: From Peace Negotiations to Human Rights."

David Hakken, Ph.D., professor of anthropology at SUNY Utica/Rome, said, "It is a rare opportunity and a distinct honor to have Professor Sejersted offer his experiences as chair of the Nobel Peace Prize Committee and his wisdom as a renowned scholar during his brief visit to our area."

Dr. Hakken and Nigel Young, director of the Peace Studies Program at Colgate, cooperated to bring Sejersted to the campuses. The lectures were co-sponsored by the Science, Technology and Society Program at SUNY Utica/Rome and the Peace Studies Program at Colgate.

In addition to his service on the Nobel Peace Prize Committee, Sejersted is a professor of economic and social history and the director of the Center for Technology and Culture at the University of Oslo, Norway. He is the author of 10 books and several articles dealing primarily with history, economics, democracy and political strategy.

College Prepares to Join Innovative SUNY Learning Network

SUNY Utica/Rome has been chosen to participate in an innovative high technology educational initiative that allows students to work on bachelor's and master's degrees from their homes, via the World Wide Web.

According to Thomas Tribunella, SUNY Utica/Rome assistant professor and director of the accounting program, the college has been provided with grant funds that will allow it to offer the master of science degree in accountancy through the SUNY Learning Network.

Academic offerings through that network will use the Internet to deliver graduate courses to students anywhere in the world. State-of-the-art technology will be used to help create a virtual college on the World Wide Web, said Tribunella

The master of science degree in accountancy is a new program at SUNY Utica/Rome and allows accountants to prepare for the Certified Public Accountant examination and to meet the proposed change in the law that will require CPAs to have at least 150 credit hours. The college will offer five courses on the SUNY Learning Network beginning with the fall 1998 semester and another five in spring '99.

"This could be the most convenient and ef-

fective way for accountants to continue their education," said Tribunella. "This new program eliminates the problems of long commutes, child care, conflicting work schedules, and absences due to illness."

The cost of providing the courses through the SUNY Learning Network are being covered through a grant written by Tribunella and Shirley Van Marter, Ph.D., executive vice president for academic affairs at SUNY Utica/Rome.

The SUNY Learning Network is supported by the Alfred P. Sloan Foundation, SUNY System Administration — Office of Advanced Learning & Information Services and the Center for Learning & Technology. The SLN is an Asynchronous Learning Network, a new approach to teaching and learning that is student centered.

ALN also emphasizes innovative instruction and learning. The activities of a traditional class are the same — students read course materials, write papers, do research, and communicate with their instructor and fellow students. The students and the faculty use technology to accomplish these tasks. The course design facilitates these activities through a computer network. The learning is both inter-

active with faculty and collaborative with other students. Faculty and students can also leverage the wealth of resources available through the Internet to support this instruction.

Students may take degree programs or just a few courses in the ALN format to complement their oncampus studies.

Using computers either from home or at a local campus, students have had the opportunity to select from four courses in both fall '95 and spring '96 semesters. There were 14 courses offered in the fall '96 semester: five in liberal studies, five in business, and four community-college-level courses. There were 19 courses offered in the spring '97 semester, more than 75 courses offered

in fall '97 and more than 100 in spring '98.

This growth in the course portfolio is representative of the plans to expand the SLN within the SUNY System. This innovative program also supports Rethinking SUNY, specifically, in terms of goals to increase sharing/exchange of courses across campuses, to enhance access

In November, world renowned jazz violinist Claude "Fiddler" Williams came to SUNY Utica/Rome with his unique brand of Kansas City-bred swing, blues and balladry as he performed in Kunsela Hall Auditorium before a crowd of more than 100 listeners.

Williams, who turned 91 in February, has been performing for 77 years and has developed his style while playing with musical legends such as Count Basie, Nat King Cole, Charlie Parker and Lester Young. In the past several years, Williams has been featured on "CBS News Sunday Morning," performed at Carnegie Hall and opened Lincoln Center's "Kansas City Swing and Shout." He also played for President Clinton's inaugural.

His recent recording "SwingTime In New York," has received critical acclaim from jazz enthusiasts internationally. A "Washington Post" review said Williams plays "with infectious spirit as he cuts a wide swath through decades of swing, blues and pop." A "New York Times" concert review last year stated, "He made the instrument a smooth-talking tease, sly and ebullient, with phrases that sounded like classy, witty wolf whistles."

The legendary musician, often referred to as "the swinging-est violinist in jazz," also performed for area elementary and high school students during his brief stop in the litica area.

nificant periods of her life. It includes memories of being raised in a family that refused racial prejudice, learning African history from W.E.B. DuBois, working for Paul Robeson, marrying a man of Jewish heritage and struggling to write during a losing battle with cancer.

Van Dyke's work was applauded in *The New York Times*, whose critic wrote, "In *Love to All, Lorraine*, Van Dyke presents a portrait of Lorraine Hansberry that sums up a great range of black experience in this century ... What she evokes best is the almost terrifying intelligence and honesty of Miss Hansberry, and the peculiar mixture of humor and anger that was hers."

Van Dyke has starred in several stage performances around the country and might be recognized for her appearances on shows such as "Ryan's Hope," "All My Children," and "Saturday Night Live."

The event was partly funded by the Central New York Community Arts Council Decentralization Program, made possible with funds from the state Council on the Arts. It is co-sponsored by the Cultural and Performing Arts Committee of SUNY Utica/Rome, and the Institute of Technology Foundation at Utica/Rome.



Flamboyant 'Cyberskeptic' To Address '98 Graduates

Internationally renowned astronomer and author Clifford Stoll will address graduates at the college's 24th annual commencement exercises at the Utica Memorial Auditorium on Saturday, May 9.

For the first time, the college will conduct a morning ceremony, with the procession beginning at 10 a.m.

Stoll, arguably the most colorful and flamboyant contemporary high technology guru, proudly wears the crown of "cyber skeptic."

An astrophysicist and astronomer, through his insatiable curiosity -- and some would argue, his compulsive nature -- he authored one of the most critical entries in the short, but eventful, history of cyberspace.

While working as a systems manager at Lawrence Berkeley Lab at the University of California at Berkeley, Stoll discovered a 75-cent accounting error. That discrepancy alerted him to the presence of an unauthorized user of the computer system. Stoll's search for the intruder, who had deceptively and discretely maneuvered through a maze of military and research computers, led to an international spy ring that sent shockwaves through security and intelligence organizations throughout the world.

Stoll spent an entire year tracing the careful computer tracks of the high-level hacker and uncovered that the intruder used a variety of methods, some more sophisticated than others, to enter computers and collect critical data. Some strategies were as simple as guessing passwords; others included exploitation of software

bugs, and the creation of bogus programs.

Stoll's search through computer networks all over the world, led him to Hannover, Germany, where he found a hacker linked to an agent in Pittsburgh. The startling discovery was of a spy ring that sold computer secrets to the KGB for cocaine and tens of thousands of dollars. That ring was broken in March 1989 and Stoll was acclaimed an American hero on the cover of major newspapers across the country.

His experience also led to his book, *The Cuckoo's Egg: Tracking a Spy Through the Maze of Computer Espionage*, that quickly vaulted to the New York Times best-seller list. Part of the path Stoll followed was to try to convince the Central Intelligence Agency, the National Security Agency and the Federal Bureau of Investigation that there existed a serious threat to military computers and the confidential data contained within their systems. After more than a year, the agencies believed Stoll.

Looking more like an anti-establishment 1960s protestor than the person who uncovered an international espionage plot, Stoll's first book contains all the suspense of a classic spy novel in dealing with what many have called the most important security issue of the 1990s. His talk to graduates proves to be inspirational and entertaining.

Also receiving an honorary degree at this year's commencement will be Oneida Indian Nation federal representative Ray Halbritter.

Shirley Van Marter, executive vice president for academic affairs, presents the initial scholarship fund check in the name of John Falcone, who retired as vice president for administration this past February.

Falcone Leaves Vice President's Position

John A. Falcone, who served as vice president for administration at the college since 1990, retired this past February.

The Alumni Association will officially name Falcone an honorary alumnus at Fall Fest '98 in September.

Falcone was responsible for the overall administration and management of the college's business and financial affairs and served as vice chair and executive officer of the college Auxiliary Services Corporation. He also was chief executive officer and vice chair of the Institute Foundation.

Prior to his tenure at the Institute of Technology, Falcone served for nearly 20

years as vice president for finance and treasurer at Lafayette College in Pennsylvania. He also spent six years as the controller at Colgate University.

In 1995, Falcone received the Distinguished Business Officer Award from the National Association of College and University Business Officers. The award is the association's highest tribute and recognized Falcone's outstanding achievement in the field of business and financial management in higher education. A long-standing member of NACUBO, at one time Falcone served as president of that organization.

School Adds Finance Concentration

Because of the continual excitement generated by Wall Street, finance is the hottest field in the world today, according to Sanjay B. Varshney, Ph.D., assistant professor of finance at SUNY Utica/Rome and a chartered financial analyst. Partly for that reason, SUNY Utica/Rome has added a concentration in finance to its master of science in business management.

Finance is also a very lucrative field, according to Dr. Varshney. The average salary for a person holding a bachelor of science is \$35,000. If a person has an MBA from one of the top 20 business schools that number goes up to a range of \$90,000 to \$120,000. A charted financial analyst or portfolio manager enjoys a base salary of \$250,000 to \$500,000 annually with bonuses of \$1 to \$2 million, he said.

"Most people looking for an MBA concentrate on accounting or finance, but our degree will be more attractive," Dr. Varshney said. He believes SUNY Utica/Rome is a better choice for three reasons. First, the college is state-supported, therefore, tuition is more affordable than at most private schools. Second, the campus is centrally located, and, finally, Dr. Varshney believes the college has a more marketable degree.

"Unlike most campuses, the credentials are on this campus," he said. "The finance program is not taught by adjuncts. Our instructors are credentialed to teach these courses. All of our instructors have Wall Street experience. That is what makes us more marketable."

Dr. Varshney, who also coordinates the finance program, will be teaching the majority of courses. To satisfy the concentration requirements a student must complete five finance core courses, including finance management problems, investment strategy, financial institutions and markets, portfolio management, and financial environments and strategies.

Students who have a non-finance or non-business bachelor of science degree and want to participate in this concentration, must successfully complete marketing, accounting, computer usage, business statistics, finance, and organizational behavior. Dr. Varshney said to make requirements reasonable for potential students in this category, one-credit-hour modules were being developed to help determine if students would require the three-credit-hour courses.

Professors Talk Business on TV

Dr. Varshney and Edward A. Petronio, assistant professor of management at SUNY Utica/Rome are featured on a television show that deals with individual investing and personal finance.

"The World of Finance," a half-hour program produced at SUNY Utica/Rome's oncampus studio, airs in the Utica area on Harron Communications cable channel 34 on Mondays at noon and again at 6:30~p.m.; on Wednesdays at 7~p.m.; Thursdays at 10~a.m. and again at 7:30~p.m.; on Fridays at 2~p.m.; and Saturdays at 2~p.m.

The show is designed for individual investors and covers terminology of investing. Viewers will learn about stocks, bonds and other financial instruments.

The shows are moderated by Mike Chalmers, the money editor at the Observer Dispatch in Utica, and Linda Murphy, money reporter at the O-D.

Dr. Varshney said that he and Dr. Petronio are planning to answer viewers' questions, submitted by phone, mail or e-mail. 
